Note: In order to receive the discount, EFT must be set up as payment method going forward. The 2009 dues must be paid in full (full amount less 2% discount). In future years (2010, 2011, 2012 etc.) you may choose to make advanced payments either monthly (total 2009 dues less 2% divided by 12 months, first payment due on January 1, 2009), quarterly (total 2009 dues less 2% divided by 4, first quarterly payment due on March 1, 2009) or annually (2009 dues, less 2%, paid on December 15, 2009). In the event you choose monthly or quarterly and the dues increase, your last monthly statement for the year will be adjusted by the amount of the increase.
